## Chief's Report - November 21, 2018

## 1) Police Facility update

The Chief advised that construction is on budget and on schedule. He advised that they hope to have the roof on by mid-December to allow for interior work during the winter months. He advised the concrete floor is poured and the building steel should be delivered very soon.

## 2) Sex Offender Registry S.O.R. Site Assessment

The Chief advised that OSOR conducted an audit of the Services S.O.R. The audit focused on records management, SIP entries, statistics and status. He advised the overall audit was excellent with no suggested improvements for our Service. He noted that Cst. Greg Fletcher manages the S.O.R for the Service.

3) R.I.D.E. Grant

The Chief advised that the Saugeen Shores Police Service received an R.I.D.E. Grant for 2018-19 in the amount of \$8,840.00. He advised that the Services have begun the festive R.I.D.E. Program focusing on impaired driving resulting from alcohol and drug consumption.

4) St. John Ambulance Provincial Life Saving Award

The Chief advised that on November 12<sup>th</sup>, Cst. Laurel Hopkins was presented with the St. John Provincial Life Savings award at the Council meeting. Cst. Hopkins saved two lives in 2018 by administering Naloxone.

5) Police Records check

The Chief advised that the Ministry has updated the records check legislation to three types of checks -

1) Criminal records;

2) Criminal records and judicial matters;

3) Judicial matters and vulnerable sector checks.

He advised that the Service has updated our forms internally, on our website and on our online records check system to be compliant with the new legislation.

6) Community Drug and Alcohol Strategy

The Chief advised that he sits on the leadership table for the Community Drug and Alcohol Strategy, the Cannabis strategy, the Opioid strategy and the Human trafficking strategy. He advised that he has been asked to sit on the Steering Committee.

Following is an update on these strategies:

Cannabis

"Weeding out the Myths" information nights have been completed in Grey and Bruce and the attendance averaged 50 people at each session.

On the 26<sup>th</sup> of November, the School Board, Grey Bruce Health Unit and School Resources officers for Grey and Bruce are meeting to discuss strategies for information sessions to be delivered to high school students relating to impaired driving by drugs.

The intention is to have information to students prior to the Christmas break followed up by actual classroom sessions by Police, Grey Bruce Health Unit and school officials to enure a consistent message is being delivered. He noted this is an important education and awareness project.

Opioid Strategy

The Chief advised that fentanyl and carfentanel continues to be a problem in Grey and Bruce counties. The Opioid committee is gathering data from emergency rooms, paramedics and Police to get a clear picture of opioid overdoses.

The Opioid Working Group and Grey Bruce Public Health will continue to coordinate Overdose Awareness Day events for the future.

## **Human Trafficking**

Victim Services has hired an anti-human trafficking co-ordinator who will be attending high schools in Grey and Bruce to discuss education and awareness for staff. The co-ordinator has made contact with Saugeen District Secondary School to organize a staff information session.

The Chief advised that Cst. Sacks is planning a presentation at the Plex and that all hotel managers will be invited.

## **Violence Prevention**

The Chief advised that Violence Prevention Grey Bruce have developed a "Working Together" protocol in 2018. The protocol addresses a community response to those who are victims of domestic or sexual violence. The SSPS hosted a training session for VPGB staff to present the protocol to supervisors who will in turn share the information with officers to better serve victims of crime. The protocol is informative and accessible for victims and Police to assist in referring victims to the appropriate social agencies. The protocol link will be added to the SSPS website.
