7. REPORTS

Chief's Report - December 2020

1) New Constable Cadet

The Chief advised that Cassandra Hahn has successfully passed all background checks and will be attending the Ontario Police College in January 2021 as a Police Constable Cadet.

2) Request to post internal position

The Chief advised that internal interest has been shown for Support Services 3 – front counter position and is asking permission to post for this position internally.

3) Post externally for experienced Constable

The Chief requested permission to post externally for an experienced Constable if the Support Services 3 – front counter worker is filled by an internal Officer.

Motion 3 – Pat O'Connor/Don Matheson

That the Saugeen Shores Police Services Board grants permission to Chief Zettel to post internally for a Support Services 3 – Front Counter person;

And further if the position is filled internally that permission is granted to post externally for an experienced Constable position.

4) Special Investigations Unit Act 2019

The Chief advised that in March 2019, Bill 68, The Comprehensive Ontario Police Services Act, 2019 (COPS Act) received Royal Assent.

The SIU Act will -

- establish the SIU as a fully independent provincial agency;
- require the SIU to investigate any discharge of a firearm at a person by an official regardless of whether serious injury or death occurred;
- remove the ability of the SIU to investigate criminal conduct of policing officials outside of its mandate;
- permit the SIU to investigate Special Constables employed by the Niagara Parks Commission and peace officers in the Legislative Protection Service, in addition to Police Officers, and;
- require the SIU to report publicly on investigations that take more than 120 days to complete and release further updates every 30 days thereafter.

5) Civil Remedies Grant

The Chief advised that he has prepared 2 grant applications for this grant. One being Project Lifesaver in the amount of \$13,987.98 and Digital Evidence Retrieval system in the amount of \$45,807.51.

6) Policy Review

The Chief advised that the Police Service policies and procedures are being reviewed and should be completed early in the new year.

7) N.C.A.C.R audit and submission

The Chief advised he was notified November 22, that the N.C.A.C.R. Submission is due. This is required to ensure the security of all services in our co-operative and that Chris Hill will be completing this as part of our contract services with Owen Sound Police Services IT.

8) Community Safety Well being Plan (CSWBP)

The Chief advised that we are nearing the completion of the Community Safety and Well Being Plan for Grey and Bruce Counties and that Sarah Cowley presented this to Council and Board on December 14th.

9) Public Safety Portal Training

The Chief advised that all members utilizing our NICHE RMS are required to complete on line training course to ensure that the use is lawful and within the guidelines set out by CPI Centre. This training is anticipated to be completed by the end of December 2020.

10) Confined Space Training

The Chief advised that in accordance with All Chief's memo #20-0164 received November 25th, 2020, the Ontario Police Health and Safety Committee (OPHSC) Guidance Note #20 – that all Police Service workers should be aware of confined spaces and the dangers that they present.

The Chief advised that he has made arrangements for online training for all Police officers and Special Constables through Candie Blackburn. The training cost is \$49.00 per member and should be completed by mid January 2021.

11) Events

The Chief advised the following events have taken place -

- Reverse Santa Claus parades for Port Elgin and Southampton
- Christmas Fund raiser in Scone December 5
- Iota Phi Sorority on behalf of the Salvation Army food and toy drive

12) COVID-19 update

The Chief advised the Town of Saugeen Shores has received a COVID-19 grant. Members of the Service must use their key fob at the station.

Vehicles are cleaned after use and after any transportation of people taken to the station.
