3. **Declaration of Pecuniary Interest**

4. **Delegations**

1) Presentation of Service Plaques and Federal Scrolls to Dave Myette and Don Matheson

Chief Zettel and Chair O'Connor presented plaques to former Saugeen Shores Police Board Members, and thanked them for their years of service. The presentation to Zack Mowbray was postponed.

2) Carl Anderson - CARFAX

Mr. Anderson presented to the Board on CARFAX Canada ULC, formerly known as CarProof. It is a web-based program that tells the history of a car from beginning to end, in chronological order. It is a useful tool to assist Law Enforcement Agencies with: vehicle history information; partial Licence Plate recognition; VIN alerts; high mileage alerts; driver exchange and crash report center. Their headquarters are in the USA and have a Canadian base in London Ontario. Once the Police Service signs up, the information is free. Currently they have over 5,400 Agencies and 90,000 Police Services, including Toronto, Guelph and Hamilton.

It was confirmed that CARFAX is a free service for Police Agencies, in trade for information exchange. The more Agencies they have on board, the more accurate the information is. They make their money when people do a vehicle search, and pay the fee.

Chief's Report

Personnel

1) Officer Spotlight – Greg Fletcher

As highlighted in the Saugeen Shores Police Service 2023-2025 Strategic Plan prepared by the Police Services Board, a strategic area of focus was to promote continued communication between service members, leadership, and the Board with the intention of enhancing member participation in identifying and implementing solutions to service needs. During each meeting, we will highlight one of our officers to share with the Board their valued contributions to the police service and community. Inspector Mighton gave a presentation on Greg Fletcher.

2) Officers – Life Saving Efforts

The Chief is very proud of our great group of officers. So far in 2023, they have had 2 separate incidents that they responded to, that involved outstanding efforts on behalf of our officers to save the lives of the people involved. Without our officers' actions, the outcome would not have been the same.

3) Posting for Full-time Contract Special Constable Position Pending budget approvals, we will be hiring a Fulltime contract Special Constable at the end of March 2023. If this position is filled internally by a uniformed member, we will be required to backfill the position with a new experience hire. In preparation for this possibility, he will be posting externally for an experienced officer position to allow us to meet the timelines required for the transition. If the budget is not approved by Council, we will cease the process.

4) Thank you – Cst. Gordon & Sgt. Primeau – Use of Contingency Fund A Facebook thank you was received from a member of the public to 2 female officers who assisted her during a difficult time by providing her with supplies, a meal and lodging for the evening while waiting for ongoing assistance from social services. This kind gesture by our officers truly made a difference for this person.

5) Cst. Ian Clark – Request for Secondary Activity

Constable Ian Clark is seeking permission to engage in secondary activity with potential employment as a Volunteer. Although Cst. Clark has not been provided with a letter of offer at this time, he is proactively seeking approval to streamline the process. Constable Clark advises that the employment opportunity would not interfere with his policing duties and understands that it shall not impair the performance of his duties as a police officer with the Saugeen Shores Police Service, nor will he place himself in a position that could become a conflict of interest. Under the Police Services Act, requests for secondary activities requires permission. Unless the SSPS Board objects, he will respond in writing and grant permission.

6) Cst. Kaitlyn Schenck – Request for Secondary Activity

Cst. Kaitlyn Schenck is seeking permission to engage in secondary activity employment with the Bluewater District School Board as a supplementary (supply) teacher. Cst. Schenck advises that the employment opportunity would be a part time / as needed status that would not interfere with her employment with the Saugeen Shores Police Service. School locations would be outside of the area, therefore there would be no conflict of interest with schools in Saugeen Shores. Unless the SSPS Board objects, he will respond in writing and grant permission.

Personnel Training

1) In service Training - CROMS

Sgt. Ken Cook has completed the in-service portion of Mobile CROMS. Mobile CROMS is a web-based collision reporting system that allows our officers to electronically prepare, submit, print and share collision reports from their patrol vehicles. He added that they utilize in service training, to save on training costs.

Ministry Reports

1) 2022 Missing Person Act Annual Report

The Chief has completed the 2022 Missing Person Act Annual Report on the use of Urgent Demands, and has submitted the report to the Ministry as required. The report will be posted on the Saugeen Shores Police Service website.

2) Criminal Intelligence Service Canada – Memorandum of Understanding (MOU) On January 31st 2023, the Saugeen Shores Police Service entered into a MOU with the Criminal Intelligence Service Canada (CISC). The memorandum outlines the services responsibilities for access and use of the Automated Criminal Intelligence Information System (ACIIS). Our criminal investigations unit members and Inspector Mighton will be receiving training on ACIIS to strengthen our intelligence gathering and sharing abilities.
